## **Brief Project Description**

Tanzania is endowed with fossil fuels and minerals (referred to as "extractives" in this project).

It has large proven natural gas reserves, some of which already exploited, and extensive areas under oil exploration licenses. Exploration for gas and oil along the coast has significantly increased in recent years. Tanzania is also the fourth biggest producer of gold in Africa, accounting for about 2% of the world production, and Switzerland counts among its major importers of gold. Yet, the contribution of the extractive sector to a broad-based development benefiting Tanzanian citizens remains sub-optimal.

There are many inter-related explanatory factors for that. Those on which this project focuses include the low level of transparency and accountability prevailing in the extractive sector, and the persistence of poor mining and business standards in the Artisanal and Small-Scale Mining (ASM) subsector. The ASM subsector remains overall an informal, rudimentary, precarious, dangerous, environmentally detrimental and low livelihood subsector while more and more people are lured into it.

Against this background, this project is structured around the following two expected outcomes and related six core activities:

- **Project Outcome 1:** Enhanced level of transparency and accountability in the extractive sector.
  - **Core Activity 1.1:** Support PWYP/HakiRasilimali to implement key elements of its strategic plan.
  - **Core Activity 1.2:** In-kind and operational support to PWYP/HakiRasilimali to support its secretariat.
- **Project Outcome 2:** Improved mining and business standards in the ASM subsector
  - **Core Activity 2.1:** Support the Learning and Leadership Group (LLG) to implement key elements of the ASM Dialogue Roadmap and Action plan.
  - **Core Activity 2.2:** In-kind and operational support to the ASM National Dialogue process and the Learning and Leadership Group (LLG).
  - **Core Activity 2.3:** Contribute to the development of "model ASM mines" and to the production and export of "Fair Gold".
  - **Core Activity 2.4:** Extractive sensitization in Switzerland.
