## **Brief project description**

*Narrative Description:* In India, extreme gender inequality is manifested in high levels of violence against women particularly domestic violence (DV). DV is a human right violation and a great barrier for women empowerment and gender equality. But on account of deep-rooted gender biased social norms, perpetration and condonation of DV continues. Many times, the DV survivors do not get necessary support from the community and also from the government. Hence, this project focuses on prevention of DV as well as facilitation of service provisions for the DV survivors to live a violence free life.

*Outcomes:* (i) Improvements in gender equitable behaviour of young boys and men in the project communities, (ii) Improvements in gender equitable behaviour of young girls and women in the project communities, (iii) Support services to overcome domestic violence are available and accessed by the girls/ women survivors of domestic violence, (iv) Effective engagement of the civil society organisations with government officials(v) Organizational capacities of civil society organizations strengthened to deliver their respective mandates more effectively.

*Strategies:* [1]\_Adoption of Gender Transformative Approaches (GTA), [2] Strengthening ability of the project communities to respond to DV with a gender perspective, [3] Engaging government stakeholders for multi sectoral coordination of response and referral to DV survivors, [4] Empowering girls/women survivors of domestic violence and other vulnerable girls/women, [5] Outreach strategies, and [6] Developing capacities of the partner organizations for implementing a holistic program to address DV and for sustainability.

*Beneficiaries:* The project will be implemented in 100 villages of 4 districts of Marathwada. They consist of 30571 households and a total population of 1, 50,486 of which, female population is 72,585. The total number of beneficiaries under the project would be 6600 unmarried boys between the age group 18 to 24,9600 unmarried girls in the age bracket of 11 to 19, 22800 married men in the age group of 13 to 49 and 24600 married women in the age bracket of 13 to 49 years.
