Brief project description

This project will reach 400 direct beneficiaries (approx. 50% women) from small-holder farmer and landless households in 10 villages in Momauk Township, Kachin State. The project aims to promote sustainable livelihoods and resilient, socially cohesive communities.

Key components include:

- CBO Capacity Building. The project will support village-based groups to gain increased knowledge, skills, and organizational capacities for participatory livelihoods development planning and implementation, and to engage with the public and private sector. Activities also aim to build increased co-operation between different groups within communities, and between communities.
- Increased livelihoods opportunities. The core activities are a) capacity building for household livelihoods improvement and b) provision of investment funds for value chain engagements. Women and men who have self-organised into CBOs will be supported to improve their livelihoods and incomes. Especially-vulnerable households will receive specific support to reduce their unsustainable debt. On-farm activities will increase income through productive agroecological value chains. Off-farm incomes are focussed on opportunities for diversifying livelihoods. This component also includes activities for awareness raising on land tenure / land laws.
- Women's empowerment. The core activity is commitment and skills building for women's empowerment and leadership. Women will be supported to gain increased confidence and capacities to drive their own development agenda. Awareness-raising with both men and women on the co-responsibility of men will be carried out. Networking between community-based women's groups will be supported for shared learning and advocacy.
- Partner capacity support. This will include in community organizing; ecological agriculture; value chains / market approaches; gender and women's empowerment; evidence-based advocacy; and monitoring and learning systems.
